

## PROJECT SPOTLIGHT




InfraNomics co-authored the ground-breaking industry report *Lithium Valley: Establishing the Case for Energy Metals and Battery Manufacturing in Western Australia* in 2018. More than just an analysis of the current new energy materials market, the report made a number of highly innovative recommendations for government and industry.

The report has received significant national and international attention and has inspired State and Federal taskforces and the development of a Federal strategy for fostering a new energy materials industry in Australia.

InfraNomics is now working with various levels of government and industry to implement the report's recommendations, build the industry and turn Lithium Valley into the global hub for new energy materials.
